# Update on the 27<sup>th</sup> Donne Conference in Leiden

Plans are taking final shape for the 27<sup>th</sup> John Donne Conference, 26 – 29 June, 2012, in Leiden, the historic city that Donne visited as part of the Doncaster embassy to Holland in 1619–1620. Rich in the history both of Protestantism and of the formation of the Netherlands as a nation-state, Leiden is an ideal setting for us to continue our ongoing conversations about Donne, not only because of Donne's brief connection with it, but also because it was an important place for other important seventeenth-century English writers as well, especially Richard Crashaw and Sir Thomas Browne. The conference will be held on the campus of the University of Leiden in the Scaliger Institute (http://scaligerinstitute.leidenuniv.nl).

The program committee, chaired by JDS President Raymond-Jean Frontain, is nearly finished with its deliberations, and notifications about the status of submissions should go out in early January. The main base of accommodations for conference attendees will be the Golden Tulip Leiden Centre (<a href="http://www.goldentulipleidencentre.nl/">http://www.goldentulipleidencentre.nl/</a>) and the Tulip Inn Leiden Centre (<a href="http://www.tulipinnleidencentre.nl/">http://www.tulipinnleidencentre.nl/</a>). Both hotels are within walking distances of the Scaliger Institute (approx. 10–15 minutes walk). The price per room is €105 (Tulip) and €125 (Golden Tulip), and up to two people may share a room. Breakfast is an additional €16 per night. To obtain the conference rate, registrants must contact the chosen hotel directly and book their reservations with a special code (118618) before 1 February.
